**NOTES:**

- 1) The fixed charges are per AWB/HAWB/Declaration.
- 2) All calculations are based on Chargeable Weight.
- 3) The total fee to be collected is calculated as rounded up and in multiples of TL 5.
- 4) The transit additional storage fees specified in items 9.1 and 9.2 are being applied starting from the first storage day for transit cargoes waiting in Istanbul for more than 7 days upon customer request.
- 5) If there are carriages (if any) required for returns due to customer's fault, they are charged separately. Additional necessities are included in the invoice

separately.

6) CAO (Cargo Aircraft Only) carriages are not accepted for transfers to domestic bonded stations. However, they may be performed upon agreement of Turkish Airlines, provided that the consignor and/or consignee have obtained all the necessary permissions for transfer of such cargoes to domestic bonded stations and also accept all costs to be incurred on the transit route with the vehicle to be supplied.

7) In case of truck transports to bonded stations upon customer's demand, the customer is charged for the per vehicle carriage fees in addition to the fixed prices.

8) This is applicable to Istanbul only.

9) If transit cargo is to be changed as IST delivery, import tariff is applied.

10) Warehouse fees are calculated according to the tariff effective from the time the cargo arrives at the warehouse.

11) Crane and forklift fees for single piece cargo of 3 tons or more are charged to the customer.

12) ULDs that are lent, will be priced at the rates which specified in the "ULD Replacement, Rental and Repair Schedule".

13) Wheelchair shipments that are not more than one, are not transported for commercial purposes and when the consignee is not arranged as a legal entity in the bill of lading, these shipments are exempted from the above tariffs upon instruction of the Disability Health Board Report.

14) 10.15.1 - AVI Care service is applied to all cat and dog shipments regardless of customer request. For other animal species, it is applied based on customer request and in cases of necessity. The service includes veterinary check, specialized handling regarding live animal transportation and cleansing services. The service is charged per AWB.

10.15.2 - TK Live Pet Supervision Service includes walking, escorting on tarmac, photo sharing processes and real time communication service. The service is charged with according to number of kennel. Those shipments having 7 or more kennels are charged with the maximum price, \$1400.

10.15.3 - TK Live DOC (Day-Old Chick) Supervision Service includes escorting on tarmac and photo sharing processes.
