NOTES:

- 1) The charges are per AWB/HAWB/Declaration.
- 2) All calculations are based on Chargeable Weight.
- 3) During the payments, the TL equivalent of the charges informed in foreign currency is calculated over the R.O.T Central Bank effective selling rate of exchange at the date when the payment is made. Besides, the price in equivalent TL is calculated as rounded up and in multiples of TL 5.
- 4) In case of non-consolidated transport, the storage fee is calculated as based on the entry of the last cargo to the warehouse. In case of consolidated transport, this implementation is based on the House AWB.
- 5) This is applicable to Istanbul only.
- 6) For all off-hour transports, the overtime pays specified in 4.1 and 4.2 are collected additionally.
- 7) A service fee of \$ 0,02 is collected per kilogram in addition to the total price.
- 8) Warehouse fees are calculated according to the tariff effective from the time the cargo arrives at the warehouse.
- 9) Crane and forklift fees for single piece cargo of 3 tons or more are charged to the customer.
- 10) ULDs that are lent, will be priced at the rates which specified in the "ULD Replacement, Rental and Repair Schedule".
- 11) Wheelchair shipments that are not more than one, are exempt from customs, are not transported for commercial purposes and when the consignee is not arranged as a legal entity in the bill of lading, these shipments are exempted from the above tariffs upon instruction of the Disability Health Board Report.
- 12) AVI care fees are applied for pets (PET) upon customer request and in cases of necessity.
- 13) 2.16.1 - The service includes AVI cleansing, veterinary check, feeding and watering services. The service is charged per AWB.
- 2.16.2 - TK Live Pet Supervision Service includes walking, escorting on tarmac, photo sharing processes and AVI Care service (AVI cleansing, veterinary check, feeding and watering services). The service is charged with according to number of kennel. Those shipments having 7 or more kennels are charged with the maximum price, \$560.
- 2.16.3 - TK Live DOC (Day-Old Chick) Supervision Service includes escorting on tarmac and photo sharing processes.
